Heavy rains on Aug 12th resulted in a culvert failure on IL 160 ~ 2.7 miles south of IL 140 and the closure of IL160 from Pocahontas Rd to IL140 in Grantfork. The contractor will remove the pavement, make temporary subgrade repairs and backfill to re-establish operations. Once the needed final materials are obtained, the Contractor will replace the culvert, install rip rap on end sections for protection and patch the pavement.
