Reason for selection of this particular contractor/vendor: Keeley was selected to perform this work based on their excellent working relationship with D8 and the good work they have done for us in the past under similar urgent situations. Keeley is already a contractor on an adjacent project working on the Poplar Street Bridge, roughly 250' away from this location. This limits conflicts and eases traffic control coordination between the two contracts. Keeley will be able to begin immediately, needed repairs to restore the bridge deck and the React attenuator to a safe operating condition. Additionally, Keeley has the available resources, staff and expertise to address the possible "worst-case" issues which have created these highway safety issues - reducing the potential risk/loss to the state. Description of services and/or supplies to be provided: This work is anticipated to include repairs to the bridge deck and back parapet wall along with installing a new React attenuator that were damaged in an accident on October 21, 2019 under MCHD Claim #818118. The new attenuator is being provided by District 8 Operations.
