Reason for selection of this particular contractor/vendor:

Keeley was selected to perform this work based on their excellent working relationship with D8 and the good work they have done for us in the past under similar urgent situations. Keeley will be able to begin immediately, assist in determining the root cause of the failure and develop options for the needed repairs to restore the roadway to safe operating condition. Keeley will work closely with district staff to move their equipment, materials and staff to the location via ferry as there is no other access to Calhoun County due to ongoing flooding. Additionally, Keeley has the available resources, staff and expertise to address the possible "worst-case" issues which have created these highway safety issues - reducing the potential risk/loss to the state.

Description of services and/or supplies to be provided:

The recent flooding of the Illinois River and heavy rains caused a section of IL Rte 100 south of Michael in Calhoun County to fail. The road is currently closed. The contractor will perform testing and excavation to determine root cause of failure and the extent of the needed repair. The repair is anticipated to include removal and replacement of the pavement and subgrade in one lane and the foreslope.
