Contractor Execution Of Contracts & Bonds

All Vendors:

The Illinois Comptroller is rejecting a higher number of contract/bonds for payment due to the vendor's corporate seal obscuring the signatures and/or dates.

When contractors are executing awarded contracts and contract bonds, please ensure the corporate seal is affixed in a place that does not cover the authorized signatures and/or the date of signing.

Also, please note that all signatures must be dated and the Vendors TIN certification form must show the company name as it appears on the contract.

Your attention to these details will assure that there are no delays in contract execution or payment.

The 2022 PEV Program

The 2022 Profile Equipment Verification (PEV) program will be conducted by Applied Pavement Technology, Inc. this coming spring on behalf of the Bureau of Research. The PEV program is required for any Contractor or Subcontractor conducting surface profile testing using the 0.00-inch blanking band or the International Roughness Index. These projects include any of the following:

- contracts including work under Articles 407.09 or 420.10 of the Standard Specifications for Road and Bridge Construction,
- contracts including the Special Provision for Surface Testing of Hot-Mix Asphalt Overlays.
- contracts including the Special Provision for Surface Testing of Pavements - IRI.

The 2022 PEV program will be conducted in April and May. Actual dates will be posted in future bulletins. Participants in last year's program will need to have their profile equipment re-verified (this is an annual program).
