

IDOT - Bureau of Land Acquisition Contracts for Legal Services

All of the following listed attorneys have a contract with the Illinois Department of Transportation Bureau of Land Acquisition. All contracts provide that the attorney will provide legal services related to eminent domain litigation matters for the Department. All contracts state that the term of the agreement will expire on June 30, 2021. The total contract dollar amount is presently unknown because it is dependent upon the amount of work each attorney performs during the term of the agreement. IDOT EXEMPT RAILROAD AND UTILITY AGREEMENTS

The contracts listed below are exempt from the Illinois Procurement Code pursuant to Section 1-10(b)(15). The term of each contract from \$0 to \$999,999.99 is 4 years. The term of each contract over \$1,000,000 is 6 years. For Utility contracts (which contain a "U" in the obligation #, below), the contracted services provided are for the relocation of utility facilities for highway improvement projects. For Railroad contracts (which contains a "R" in the obligation #, below), the contracted services provided are for modification of railroad facilities for highway purposes.
